ACT No. XVII of 2020

AN ACT to amend the Explosives Ordinance, Cap. 33.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

1. The short title of this Act is the Explosives Ordinance (Amendment) Act, 2020, and this Act shall be read and construed as one with the Explosives Ordinance, hereinafter referred to as "the principal Ordinance".

Short title.

Cap. 33.

2. In sub-article 4(b) of the principal Ordinance the word "conductor;" shall be substituted by the word "conductor:" and immediately after there shall be added the following new proviso:

Amendment of article 4 of the principal Ordinance.

"Provided that no such wall or any other solid fence shall be required for fireworks factories;"
