ACT No. XXII of 2020

AN ACT to amend the Devolution of Certain Ministerial Powers Act, Cap. 611.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. The short title of this Act is the Devolution of Certain Ministerial Powers (Amendment) Act, 2020, and this Act shall be read and construed as one with the Devolution of Certain Ministerial Powers Act, hereinafter referred to as "the principal Act".

Short title.

2. Sub-article (2) of article 1 of the principal Act shall be deleted and sub-article (1) shall be renumbered as article 1.

Amendment of article 1 of the principal Act.

3. Article 4 of the principal Act shall be amended as follows:

(a) in sub-article (2) thereof, the words "operative date" shall be substituted by the words "coming into force of this Act"; and

(b) immediately after sub-article (2) thereof there shall be added the following new sub-article:

"(3) Any notifications, orders, schemes, rules, regulations, appointments, delegations, directions or authorisations lawfully made, given or issued and anything done prior to the coming into force of the Devolution of Certain Ministerial Powers (Amendment) Act, 2020 in accordance with the enactments which were in force prior to the 1st October, 2019 mentioned in the Schedules to the principal Act, shall be deemed to be valid and continue to be valid."
