## **ABOZZ TA' LIĠI msejjah**

*ATT sabiex ikompli jemenda l-Att dwar il-Pulizija, Kap. 164.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità tal-istess, hareġ liġi b'dan li ġej:-

**1.** (1) It-titolu fil-qosor ta' dan l-Att huwa l-Att tal-2020 li jemenda l-Att dwar il-Pulizija (Emenda Nru 3) u dan l-Att għandu jinqara u jinftiehem haġa waħda mal-Att dwar il-Pulizija, hawnhekk iżjed 'il quddiem imsejjaħ "l-Att prinċipali".

u bidu fis-seħħ.

(2) Dan l-Att għandu jidhol fis-seħħ f'dik id-data li l-Ministru għall-Intern jista' b'avviż fil-Gazzetta jistabbilixxi, u dati differenti jistgħu jiġu hekk stabbiliti għal dispożizzjonijiet differenti jew għanijiet differenti ta' dan l-Att.

**2.** Fil-paragrafu (a) tas-subartikolu (1) tal-artikolu 103 tal-Att prinċipali, il-kliem "l-età ta' ħamsa u ħamsin sena" għandhom jiġu sostitwiti bil-kliem "l-età ta' erbgħa u sittin sena".

**A BILL  
entitled**

*AN ACT to further amend the Police Act, Cap. 164.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

Short title and  
commencement.  
Cap. 164.

**1.** (1) The short title of this Act is the Police (Amendment No. 3) Act, 2020 and this Act shall be read and construed as one with the Police Act, hereinafter referred to as "the principal Act".

(2) This Act shall come into force on such date as the minister responsible for home affairs may by notice in the Gazette appoint, and different dates may be so appointed for different purposes or for different provisions of this Act.

**2.** In paragraph (a) of sub-article (1) of article 103 of the principal Act, the words "the age of fifty-five years" shall be substituted by the words "the age of sixty-four years".

Transitory  
provision.

**3.** This Act shall not apply with regard to a member of the Force who was part of the Force prior to the enactment of the Police (Amendment No. 3) Act.

### **Objects and Reasons**

The objects and reasons of this Bill are to provide the members of the Police Force who join the Police Force at the maximum age of thirty nine years of age with the possibility of receiving the twenty five year service pension.
