entitled**

*AN ACT to amend the Civil Aviation (Security) Act, Cap. 353.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

- Short title.           **1.** The short title of this Act is the Civil Aviation (Security) (Amendment) Act, 2020 and this Act shall be read and construed as one with the Civil Aviation (Security) Act, hereinafter referred to as the "principal Act".
- Cap. 353.
- Amendment of article 19 of the principal Act.           **2.** In sub-article (1) of article 19 of the principal Act, the words "liable to life imprisonment." shall be substituted by the words "liable to imprisonment from twelve (12) years to life."

**Objects and Reasons**

The Objects and Reasons of this Bill are to align the punishment relative to violence on air-crafts in flight with the punishment stipulated for offences related to terrorism.
