(a) fis-subartikolu (1) tiegħu, minflok il-kliem "bil-liġi ta' Malta" għandhom jidhlu l-kliem "bil-liġi ta' Malta jew taħtha" u minflok il-kliem "għal żmien ta' mhux iżjed minn sitt xhur jew multa ta' mhux iżjed minn elf lira, jew dik il-multa u prigunerija flimkien." għandhom jidhlu l-kliem "għal żmien ta' mhux iżjed minn sena jew multa ta' mhux iżjed minn hamest elf lira jew dik il-multa u prigunerija flimkien."; u

(b) fis-subartikolu (3) tiegħu, minflok il-kliem "fl-1 ta' Jannar, 1995." għandhom jidhlu l-kliem "fl-1 ta' Jannar, 1993.".

**ACT No. XIX of 1992**

*AN ACT to amend the Criminal Code, Cap. 9.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Criminal Code (Amendment) Act, 1992, and shall be read and construed as one with the Criminal Code, hereinafter referred to as “the principal law”.

Short title.

2. Section 298B of the principal law shall be amended as follows:

(a) in subsection (1) thereof, for the words “by Maltese law” there shall be substituted the words “by or under Maltese law” and for the words “for a term not exceeding six months or to a fine (*multa*) not exceeding one thousand liri or both such fine and imprisonment.” there shall be substituted the words “for a term not exceeding one year or to a fine (*multa*) not exceeding five thousand liri or to both such fine and imprisonment.”; and

(b) in subsection (3) thereof, for the words “on the 1st January, 1995.” there shall be substituted the words “on the 1st January, 1993.”.
