AN ACT to amend the Goldsmiths and Silversmiths Act, Cap. 46, the Malta Competition and Consumer Affairs Authority Act, Cap. 510 and other laws to assign the relative responsibility to the Malta Competition and Consumer Affairs Authority and to make ancillary and consequential provisions thereto.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:

Short title and commencement.

1. (1) The short title of this Act is the Goldsmiths and Silversmiths Act and various other Laws (Amendment) Act, 2020.

(2) This Act shall come into force on such date as the Minister for Finance and Employment may by notice in the Gazette establish, and different dates may be so established for different provisions of this Act.

Part I

Amendments to the Goldsmiths and Silversmiths Act

Amendments to the Goldsmiths and Silversmiths Act. Cap. 46.

2. This Part amends the Goldsmiths and Silversmiths Act and shall be read and construed as one with the Goldsmiths and Silversmiths Act, hereinafter in this Part referred to as "the principal Act".

Amendment of article 2 of the principal Act.

3. Article 2 of the principal Act shall be amended as follows:

(a) immediately after the definition "an alloy of precious metal", there shall be added the following definition:

Cap. 510. " "Authority" means the Malta Competition and Consumer Affairs Authority as established by article 3 of the Malta Competition and Consumer Affairs Authority Act.

(b) the definition "Consul" shall be substituted by the following:

" "Consul" means the Consul for the Goldsmiths and Silversmiths and the functions and duties of the Consul shall be discharged by the Director General (Standards and Metrology) or any public officer authorised in writing by the Director General to discharge such duties;"

(c) the definition "Minister" shall be substituted by the following:

" "Minister", unless otherwise provided in this Act, means the Minister responsible for the Authority"; and

(d) immediately after the definition "standard mark", there shall be added the following new definition:

Cap. 510. " "Standards and Metrology Institute" means the national body established under Part VII of the Malta Competition and Consumer Affairs Authority Act;"

4. Sub-article (1) of article 14 of the principal Act shall be substituted by the following:

Amendment of article 14 of the principal Act.

"(1) Valuations shall be based on the prices prevailing on the international market as prescribed."

Part II Amendments to the Malta Competition and Consumer Affairs Authority Act

5. This Part amends the Malta Competition and Consumer Affairs Authority Act and it shall be read and construed as one with the Malta Competition and Consumer Affairs Authority Act, hereinafter in this Part referred to as "the principal Act".

Amendments to the Malta Competition and Consumer Affairs Authority Act. Cap. 510.

6. Article 12 of the principal Act shall be amended as follows:

Amendment of article 12 of the principal Act.

(a) in the marginal note of sub-article (2) thereof, immediately after the words "Cap. 430.", there shall be added the words "Cap. 46.";

(b) in sub-article (2) thereof, immediately after the words "the Pesticides Control Act" there shall be added the words "the Goldsmiths and Silversmiths Act";

(c) in the marginal note of sub-article (3) thereof, immediately after the words "Cap. 430.", there shall be added the words "Cap. 46.";

(d) in sub-article (3) thereof, immediately after the words "the Pesticides Control Act" there shall be added the words "the Goldsmiths and Silversmiths Act";

(e) in the marginal note of sub-article (8) thereof, immediately after the words "Cap. 430.", there shall be added the words "Cap. 46."; and

(f) in sub-article (8) thereof, immediately after the words "the Pesticides Control Act" there shall be added the words "the Goldsmiths and Silversmiths Act".

Amendment of article 22 of the principal Act.

7. Article 22 of the principal Act shall be amended as follows:

(a) in sub-paragraph (w) of sub-article (1) thereof, the word "and" shall be deleted;

(b) in sub-paragraph (x) of sub-article (1) thereof, the words "thereunder." shall be substituted by the word "thereunder; and"; and

(c) immediately after sub-paragraph (x) of sub-article (1) thereof, there shall be added the following new sub-paragraph:

"(y) to generally exercise the responsibilities assigned to it under the Goldsmiths and Silversmiths Act and any other Act and regulations made thereunder."

Part III

Amendments to the Commissioner for Revenue Act

Amendments to the Commissioner for Revenue Act. Cap. 517.

8. This Part amends the Commissioner for Revenue Act and it shall be read and construed as one with the Commissioner for Revenue Act, hereinafter in this Part referred to as "the principal Act".

9. Article 2 of the principal Act shall be amended as follows:
- Amendment of article 2 of the principal Act.
- (a) in the marginal note of the definition "revenue acts", the words "Cap. 46." shall be deleted; and
- (b) in the definition "revenue acts", the words "the Goldsmiths and Silversmiths Act" shall be deleted.

Part IV

Amendments to the Goldsmiths and Silversmiths Regulations

10. This Part amends the Goldsmiths and Silversmiths Regulations and it shall be read and construed as one with the Goldsmiths and Silversmiths Regulations, hereinafter in this Part referred to as "the principal regulations".

Amendments to the Goldsmiths and Silversmiths Regulations.
S.L. 46. 01.

11. Regulation 14 of the principal regulations shall be amended as follows:

Amendment of regulation 14 of the principal regulations.

(a) in sub-regulation (1) thereof, the words "Minister responsible for finance" shall be substituted by the words "Minister responsible for the Authority";

(b) in sub-regulation (2) thereof, immediately after the word "Minister " there shall be added the words "responsible for the Authority";

(c) sub-regulation (3) thereof shall be substituted by the following: "The second assay shall be carried out in the presence of the person applying for it, if he so requires, and it shall be conducted by a Board made up of a professor of Chemistry in the University of Malta or some other expert designated by the Minister responsible for the Authority, in either case assisted by the Consul and by an experienced artificer also appointed by the Minister responsible for the Authority."; and

(d) in sub-regulation (5) thereof, the words "Minister responsible for Finance" shall be substituted by the words "Minister responsible for the Authority".

12. In regulation 15 of the principal regulations, the words "Minister responsible for Finance" shall be substituted by the words "Minister responsible for the Authority".

Amendment of regulation 15 of the principal regulations.

13. Regulation 25 of the principal regulations shall be substituted by the following:

Amendment of regulation 25 of the principal regulations.

"25. The official prices of gold and silver shall be based on the latest international prices as officially published by the

Central Bank of Malta and converted from troy ounces to grams using the conversion rate established in Directive 80/181/EEC.".

Objects and Reasons

The objects and reasons of this Bill are the assignment of responsibilities relating to Goldsmiths and Silversmiths from the Ministry of Finance onto the Standards and Metrology Institute within the Malta Competition and Consumer Affairs Authority.
