AN ACT to amend the Condominium Act, Cap. 398.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

1. The short title of this Act is the Condominium (Amendment) Act, 2021. Short title.

**PART I
Amendments to the Condominium Act**

2. This Part amends the Condominium Act and it shall be read and construed as one with the Condominium Act, hereinafter in this Part referred to as "the principal Act". Amendments to the Condominium Act. Cap. 398.

3. Article 24 of the principal Act shall be amended as follows: Amendment of article 24 of the principal Act.

(a) sub-article (5) thereof shall be substituted by the following new sub-article:

"(5) Any person may:

(a) inspect the documents kept by the Land Registrar;

(b) require a copy or extract of any document delivered to the Land Registrar; and

(c) request a Certificate signed by the Land Registrar or Assistant Land Registrar on behalf of the Land Registrar showing the details regarding the condominium and the administrator and rules of the condominium."; and

(b) in sub-article (6) thereof, the words "Government

Gazette" shall be substituted by the words "Gazette or Land Registration Agency website".

4. This Part amends the Land Registration Rules and it shall be read and construed as one with the Land Registration Rules, hereinafter in this Part referred to as "the principal rules".

5. In sub-rule (1) of rule 16 of the principal rules, the word "Gazette" shall be substituted by the words "Gazette or Land Registration Agency website".

Objects and Reasons

The objects and reasons of this Bill are to introduce amendments to Condominium Act with a view of publishing any rules concerning a condominium or amendments made thereto in the Land Registration Agency website in addition to publication in the Gazette.
