**A BILL
entitled**

AN ACT to amend the Conduct Certificates Ordinance, Cap 77.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

1. The short title of this Act is the Conduct Certificates Ordinance (Amendment) Act, 2021 and this Act shall be read and construed as one with the Conduct Certificates Ordinance, hereinafter referred to as "the principal Ordinance".

Short title.

Cap. 77.

2. Sub-article (4) of article 3 of the principal Ordinance shall be substituted by the following new sub-article:

Amendment of article 3 of the principal ordinance.

"(4) The request made in accordance with sub-article (3) shall be connected with:

(a) the recruitment or continued employment of a person as an employee; or

(b) the issue or renewal of a licence or permit; or

(c) an application for a residence permit or an application for Maltese citizenship submitted in accordance with the provisions of the Maltese Citizenship Act."

3. (1) The Fourth Schedule to the principal ordinance shall be amended as follows:

Amendment of the Fourth Schedule to the principal ordinance.

(a) in the title thereof, the words "Article 3(2)" shall be substituted by the words "Article 3(3)"; and

(b) immediately after the item "The Commissioner for Voluntary Organisations", there shall be added the following new item:

C 5142

"The Community Malta Agency."

Objects and Reasons

The objects and reasons of this Bill are to enable the Community Malta Agency to have access to complete record of criminal convictions.
