ACT No. XXXI of 2021

AN ACT to amend the Family Business Act, Cap. 565.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. The short title of this Act is the Family Business Short title. (Amendment) Act, 2021 and this Act shall be read and construed as one with the Family Business Act, hereinafter referred to as "the Cap. 565. principal Act".

2. In article 2 of the principal Act, the definition "Minister" shall be substituted by the following new definition: Amendment of article 2 of the principal Act.

" "Minister" means the Minister responsible for the Malta Enterprise and includes, to the extent of the authority given, any person authorised in that behalf for any purpose of this Act;".
