2. Minflok is-subartikolu (1) ta' l-artikolu 5 ta' l-Att prinċipali għandu jidhol dan li ġej: Emenda ta' l-artikolu 5 ta' l-Att prinċipali.

“(1) Din it-Taqsima għandha tapplika:

(a) għal kull organizzazzjoni li l-Ministru jista' b'ordni jiddikjara li tkun organizzazzjoni li tagħha Malta jew il-Gvern tagħha u xi Stat wiehed iehor jew Stati aktar ohrajn jew il-gvern jew il-gvernijiet tagħhom jistghu ikunu membri;

(b) għall-Bank ta' l-Investment Ewropew; u

(c) għal kull organizzazzjoni li l-Kamra tar-Rappreżentanti tista' b'Riżoluzzjoni tiddikjara li tkun organizzazzjoni li magħha Malta, jew il-gvern ta' Malta, tkun se tistabbilixxi jew tkun stabbiliet relazzjonijiet kontrattwali.”.

**ACT No. XIV of 2000**

*AN ACT to amend the Diplomatic Immunities and Privileges Act,  
Cap. 191.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Diplomatic Immunities and Privileges (Amendment) Act, 2000 and shall be read and construed as one with the Diplomatic Immunities and Privileges Act, hereinafter referred to as “the principal Act”. Short title.  
Cap. 191

2. For subsection (1) of section 5 of the principal Act there shall be substituted the following: Amendment of  
section 5 of the  
principal Act.

“(1) This Part shall apply:

(a) to any organisation which the Minister may by order declare to be an organisation of which Malta or the Government thereof and one or more other States or the government or governments thereof may be members;

(b) to the European Investment Bank; and

(c) to any organisation which the House of Representatives may by Resolution declare to be an organisation with which Malta, or the government thereof, will be establishing or has already established a contractual relationship.”.
