ACT No. I of 1999

AN ACT to amend the Income Tax Management Act, 1994.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title and
commencement.

Act XVIII of 1994.

1. (1) This Act may be cited as the Income Tax Management (Amendment) Act, 1999, and shall be read and construed as one with the Income Tax Management Act, hereinafter referred to as “the principal Act”.

(2) The provisions of this Act shall come into force on the 1st January, 1999.

2. In subsection (3) of section 32 of the principal Act, for the word “seven” there shall be substituted the word “ten”.
