ACT No. XXII of 1998

AN ACT to appropriate a sum not exceeding fifty million, one hundred and forty six thousand Maltese liri for the service of the financial year 1998.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

Short title.

1. This Act may be cited as the Second (1998) Appropriation Act, 1998.

Appropriation 1998.

2. A sum not exceeding fifty million, one hundred and forty five thousand, nine hundred and ninety six Maltese liri to meet expenditure in respect of financial year 1998 under the Votes specified in the First Schedule to this Act shall be and the same is hereby charged upon the Consolidated Fund.

Further appropriation 1998 and transfer to Contingencies Fund.

3. A further sum not exceeding four Maltese liri, to meet expenditure in respect of the financial year 1998 under the Votes specified in the Second Schedule to this Act shall be and the same is hereby charged upon the Consolidated Fund, provided that such sum shall be transferred to the Contingencies Fund in replacement of withdrawals made out of this Fund to cover the various services detailed in regard to such Votes in the Supplementary Estimates of Expenditure for the financial year 1998.
