**A BILL
entitled**

*AN ACT to amend the Code of Organization and Civil Procedure,
Cap. 12.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

- Short title. **1.** The short title of this Act is the Code of Organization and Civil Procedure (Amendment) Act, 2022 and this Act shall be read and construed as one with the Code of Organization and Civil Procedure, hereinafter referred to as "the Code".
- Cap. 12.
- Amendment of article 29 of the Code. **2.** In sub-article (1) of article 29 of the Code, the words "the Attorney General," shall be substituted by the words "the State Advocate,".

Objects and Reasons

The objects and reasons of this Bill are to continue implementing reform in the justice sector and particularly to make provision for the appointment of the State Advocate on the Rule-Making Board to replace the Attorney General on the said Board.
