*AN ACT to amend the Commissioners for Justice Act, Cap. 291.*

BE IT ENACTED by the President, by and with the advice and consent to the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. The short title of this Act is the Commissioners for Justice (Amendment) Act, 2023 and this Act shall be read and construed as one with the Commissioners for Justice Act, hereinafter referred to as "the principal Act".
