(b) għal xogħlijiet ta' fidda 959, 925, 830 u 800.

(2) It-titolu ta' finezza jkun muri bin-numru li jir-rappreżenta n-numru ta' partijiet bil-piż ta' deheb pur jew ta' fidda pura, skond il-każ, f'elf parti b'piż ta' liga."

ACT No. II of 1982

AN ACT further to amend the Goldsmiths and Silversmiths Ordinance, Cap. 74.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title
and
commencement.

1. (1) This Act may be cited as the Goldsmiths and Silversmiths (Amendment) Act, 1982, and shall be read and construed as one with the Goldsmiths and Silversmiths Ordinance, hereinafter referred to as "the principal law".

(2) This Act shall come into force on such date as the Minister responsible for finance may, by notice in the Gazette, appoint.

2. For section 4 of the principal law there shall be substituted the following:

"Standards
for gold
and silver
articles.

4. (1) The following standards of fineness shall be recognised for the purposes of this Ordinance:

- (a) for works of gold 916, 750, 585 and 375;
- (b) for works of silver 959, 925, 830 and 800.

(2) The standard of fineness shall be indicated by the number which represents the number of parts by weight of fine gold or silver, as the case may be, in one thousand parts by weight of alloy.”.
