AN ACT further to amend the National Assistance Act, 1956.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

Act VIII of
1956

Amendment of
section 12 of
the principal
Act.

1. This Act may be cited as the National Assistance (Amendment) Act, 1956, and shall be read and construed as one with the National Assistance Act, 1956, hereinafter referred to as "the principal Act".

2. Subsection (2) of section 12 of the principal Act shall be deleted.

Objects and Reasons

The Object of this Bill is to make acceptable as valid for the purposes of claims under the principal Act, medical certificates signed by medical practitioners who are also members of the House of Representatives.
