ATT biex ikompli jemenda l-Ordinanza dwar il-Kummissjunarji b'setgħa li jagħtu Ġurament, Kap. 120.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'ligi dan li ġej:—

1. Dan l-Att jista' jissejjaħ l-Att ta' l-1986 li jemenda l-Ordinanza dwar il-Kummissjunarji b'setgħa li jagħtu Ġurament, u għandu jinqara u jiftiehem haġa waħda ma' l-Ordinanza dwar il-Kummissjunarji b'setgħa li jagħtu Ġurament, hawnhekk iżjed 'il quddiem imsejjaħ "il-ligi prinċipali".

Titolu fil-qosor.

2. Minnufih wara s-subartikolu (1) ta' l-artikolu 2 tal-ligi prinċipali għandu jidhol dan is-subartikolu ġdid li ġej:

Emenda ta' l-artikolu 2 tal-ligi prinċipali.

“(1A) Il-Ministru responsabbli għall-gustizzja jista' minn żmien għal żmien, b'*warrant* iffirmit minnu, jaħtar persuni li jkunu temmew b'suċċess ir-raba' sena tal-Kors tal-Ligi fl-Università ta' Malta, li twassal għad-diploma ta' nutar pubbliku, u li jkunu jaqdu dmirijietom fl-Uffiċċju ta' l-Avukat Generali, bhala Kummissjunarji b'setgħa li jagħtu Ġurament, u jista' f'kull żmien iħassar kull haġra bħal dik.”.

L-Għan ta' dan l-Abbozz huwa li jżid in-numru ta' Kummissjunarji b'setgħa li jagħtu Ġurament sabiex ikun jista' jitwettaq il-volum ta' xogħol li żdied fl-Uffiċċju ta' l-Avukat Generali.

A BILL
entitled

AN ACT further to amend the Commissioners for Oaths Ordinance, Cap. 120.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short Title.

1. This Act may be cited as the Commissioners for Oaths (Amendment) Act, 1986, and shall be read and construed as one with the Commissioners for Oaths Ordinance, hereinafter referred to as "the principal law".

Amendment

2. Immediately after subsection (1) of section 2 of the principal law, there shall be added the following new subsection:

"(1A) The Minister responsible for justice may from time to time, by warrant under his hand, appoint persons who have successfully completed the fourth year of the Course of Laws at the University of Malta, leading to the diploma of notary public, and who are performing duties in the Office of the Attorney-General to be Commissioners for Oaths, and may at any time revoke any such appointment."

Objects and Reasons

The Object of this Bill is to increase the number of Commissioners for Oaths in the Office of the Attorney-General to cope with the increased volume of work.
