IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. Dan l-Att jista' jissejjah l-Att ta' l-1986 li jemenda l-Att dwar l-Edukazzjoni u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1974 dwar l-Edukazzjoni, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali". Titolu fil-qosor.
Att XXXIX ta' l-1974
2. L-artikolu 12 ta' l-Att prinċipali għandu jiġi emendat kif ġej: Emenda ta' l-artikolu 12 ta' l-Att prinċipali.
 - (a) is-subartikoli (2) u (5) tiegħu għandhom jithassru; u
 - (b) fis-subartikolu (3) tiegħu il-kliem "jew tiġdid" għandhom jithassru.
3. L-artikolu 13 ta' l-Att prinċipali għandu jiġi emendat kif ġej: Emenda ta' l-artikolu 13 ta' l-Att prinċipali.
 - (a) fis-subartikolu (1) tiegħu l-kliem "jew iġedded" u "jew imġedda" għandhom jithassru; u
 - (b) fis-subartikolu (2) tiegħu l-kliem "u sadattant l-ispejjeż kollha li jistgħu jsiru jibqgħu għar-responsabbiltà ta' dak is-sid u l-Gvern ikollu jedd li jdaħħal lura dawk l-ispejjeż" għandhom jithassru.
4. L-emendi li qegħdin isiru b'dan l-Att ma jolqtux xi liċenza li tkun inharġet qabel ma daħal fis-seħħ dan l-Att. Dispożizzjoni transitorja.

AN ACT further to amend the Education Act, 1974.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1974 | 1. This Act may be cited as the Education (Amendment) Act, 1986, and shall be read and construed as one with the Education Act, 1974, hereinafter referred to as "the principal Act". |
| Amendment of
section 12
of the principal
Act. | 2. Section 12 of the principal Act shall be amended as follows:
(a) subsections (2) and (5) thereof shall be deleted; and
(b) in subsection (3) thereof the words "or renewing" shall be deleted. |
| Amendment of
section 13
of the principal
Act. | 3. Section 13 of the principal Act shall be amended as follows:
(a) in subsection (1) thereof the words "or renew" and "or renewed" shall be deleted; and
(b) in subsection (2) thereof the words "and in the meantime all expenses which may be incurred shall continue to remain the liability of such owner and the Government shall have a right to the reimbursement of such expenses" shall be deleted. |

provision. | 4. The amendments made by this Act shall not affect any licence issued before the coming into force of this Act. |
