IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'ligi dan li ġej:—

1. Dan l-Att jista' jissejjaħ l-Att ta' l-1986 li jemenda l-Att dwar l-Awtorità tad-Djar, u għandu jinqara u jiftiehem hekk waħda ma' l-Att ta' l-1976 dwar l-Awtorità tad-Djar, hawnhekk iżjed 'il quddiem msejjah "l-Att prinċipali". Titolu fil-qosor.

2. Fil-paragrafu (b) tas-subartikolu (3) ta' l-artikolu 4 ta' l-Att prinċipali minflok il-kliem "l-Awtorità għandha tingeda bid-Dipartiment ta' l-Art bħala aġent tagħha" għandhom jidhlu l-kliem "l-Awtorità għandha tingeda bid-Dipartiment ta' l-Art dwar proprjetà immobbli li tkun tinsab fil-Gżira ta' Malta u bis-Segretarjat għal Ghawdex dwar proprjetà immobbli li tkun tinsab fil-Gżejjer ta' Ghawdex u Kemmuna". Emenda ta' l-artikolu 4 ta' l-Att prinċipali.

Għanijiet u Raġunijiet

L-Abbozz jipprovdj sabiex is-Segretarjat għal Ghawdex jamministra l-proprjetà immobbli ta' l-Awtorità tad-Djar f'Ghawdex u Kemmuna, bħala Aġent ta' l-Awtorità.

A BILL
entitled

An Act further to amend the Housing Authority Act, 1976

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Housing Authority (Amendment) Act, 1986 and shall be read and construed as one with the Housing Authority Act, 1976, hereinafter referred to as "the principal Act".

Short title.

2. In paragraph (b) of subsection (3) of section 4 of the principal Act for the words "the Authority shall act through the agency of the Land Department" there shall be substituted the words "the Authority shall act through the agency of the Land Department in respect of immovable property situate in the Island of Malta and through the agency of the Secretariat for Gozo Affairs in respect of immovable property situate in the Islands of Gozo and Comino".

Amendment of section 4 of the principal Act.

Objects and Reasons

The Bill makes provision for the Secretariat for Gozo Affairs to administer the immovable property of the Housing Authority in Gozo and Comino, as Agent of the Authority.
