## ABBOZZ TA' LIĠI msejjaħ

*ATT biex ikompli jemenda l-Att ta' l-1975 dwar il-Korporazzjoni Telemalta.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f' dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. Dan l-Att jista' jissejjaħ l-Att ta' l-1987 li jemenda l-Att dwar il-Korporazzjoni Telemalta (Emenda Nru. 2), u għandu jinqara u jfithem haġa waħda ma' l-Att ta' l-1975 dwar il-Korporazzjoni Telemalta, hawnhekk iżjed 'il quddiem imsejjaħ "l-Att prinċipali".

*Titolu fil-qosor.*

2. Minflok is-subartikolu (4) ta' l-artikolu 24 ta' l-Att prinċipali għandu jidhol dan li ġej:

*Emenda ta' l-artikolu 24 ta' l-Att prinċipali.*

"(4) Is-servizzi li dwarhom Telemalta hi l-awtorità esklużiva taħt l-artikolu 3 ta' dan l-Att għandhom jiġu provduti minn Telemalta lill-Gvern bil-prezzijiet, drittijiet u hlasijiet preskritti taħt id-dispożizzjonijiet ta' dan l-Att, bi skont ta' għoxrin fil-mija."

### Għanijiet u Raġunijiet

Dan l-Abbozz jipprovdi għall-hlas mill-Gvern lil Telemalta bl-istess rati li l-pubbliku jiġi mitlub iħallas għas-servizzi tagħha, bi tnaqqis ta' għoxrin fil-mija.

**A BILL  
entitled**

*AN ACT further to amend the Telemalta Corporation Act, 1975.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Telemalta Corporation (Amendment) (No. 2) Act, 1987, and shall be read and construed as one with the Telemalta Corporation Act, 1975, hereinafter referred to as “the principal Act”.

Amendment

2. For subsection (4) of section 24 of the principal Act there shall be substituted the following:

“(4) The services in respect of which Telemalta is the exclusive authority under section 3 of this Act shall be provided by Telemalta to the Government at the prices, fees and charges prescribed under the provisions of this Act, with a discount of twenty per centum.”.

**Objects and Reasons**

This Bill provides for the payment by Government to Telemalta at the rates charged to the public for its services, with a deduction of twenty per centum.
