ATT biex ikompli jemenda l-Att ta' l-1974 dwar it-Taxxa tad-Divertimenti.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'ligi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjah l-Att ta' l-1984 li jemenda l-Att dwar it-Taxxa tad-Divertimenti, u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1974 dwar it-Taxxa tad-Divertimenti, hawnhekk iżjed "il quddiem imsejjah "l-Att prinċipali".

Emenda ta' l-artikolu 8 ta' l-Att prinċipali.

2. Minnufih wara s-subartikolu (5) ta' l-artikolu 8 ta' l-Att prinċipali għandu jidhol is-subartikolu ġdid li ġej:

“(5A) Ma għandha tiġi mposta ebda taxxa fuq xi wirja bil-mezz ta' *projector* ta' films bil-video, organizzata mill-proprjetarju ta' lukanda, ristorante jew stabbiliment li jipprovdi ikel hekk liċenzjat mill-Bord dwar il-Lukandi u l-Istabbilimenti li Jipprovdu Ikel.”.

entitled

AN ACT further to amend the Entertainments Tax Act, 1974.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Entertainments Tax (Amendment) Act, 1984, and shall be read and construed as one with the Entertainments Tax Act, 1974, hereinafter referred to as “the principal Act”. Short title.

2. Immediately after subsection (5) of section 8 of the principal Act there shall be added the following new subsection: Amendment of section 8 of the principal Act.

“(5A) No tax shall be charged on any show by means of a video film projector, organized by the proprietor of a hotel, restaurant or catering establishment licensed as such by the Hotels and Catering Establishments Board.”.

Objects and Reasons

The Bill provides for exemption from entertainment tax on video film shows in certain licensed establishments.
