ACT No. IV of 1988

AN ACT further to amend the Telemalta Corporation Act, 1975.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Telemalta Corporation (Amendment) Act, 1988, and shall be read and construed as one with the Telemalta Corporation Act, 1975, hereinafter referred to as “the principal Act”.

Amendment
of section 24
of the
principal Act.

2. For subsection (4) of section 24 of the principal Act there shall be substituted the following:

“(4) The services in respect of which Telemalta is the exclusive authority under section 3 of this Act shall be provided by Telemalta to the Government at the prices, fees and charges prescribed under the provisions of this Act, with a discount of twenty per centum.”.
