ACT No. XVII of 1988

AN ACT further to amend the Attorney General and Counsel for the Republic (Constitution of Office) Ordinance, Cap. 90.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Attorney General and Counsel for the Republic (Constitution of Office) (Amendment) Act 1988, and shall be read and construed as one with the Attorney General and Counsel for the Republic (Constitution of Office) Ordinance, hereinafter referred to as "the principal law".

Cap. 90.

Amendment to section 3 of the principal law.

2. Section 3 of the principal law shall be amended as follows:

(a) in subsection (1) thereof for the words "Senior Counsel for the Republic" there shall be substituted the words "Assistants to the Attorney General", "Senior Counsel for the Republic"; and

(b) in subsection (2) thereof for the words "the Senior Counsel for the Republic" there shall be substituted the words "the Assistants to the Attorney General, the Senior Counsel for the Republic".

Amendment to section 4 of the principal law.

3. In section 4 of the principal law for the words "the Senior Counsel for the Republic" there shall be substituted the words "the Assistants to the Attorney General, the Senior Counsel for the Republic".
