ATT biex ikompli jemenda l-Att ta' l-1981 dwar il-Lotteriji tal-Gvern.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorita' ta' l-istess, hareġ b'liġi dan li ġej:—

1. (1) Dan l-Att jista' jissejjah l-Att ta' l-1988 li jemenda l-Att dwar il-Lotteriji tal-Gvern, u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' 1981 dwar il-Lotteriji tal-Gvern, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

Titolu fil-qosor u bidu fis-sehh. Att XXIV ta' l-1981.

(2) Id-dispożizzjonijiet ta' dan l-Att għandhom jitqiesu li bdew fis-sehh fl-1 ta' Settembru, 1988.

2. Minnufih wara l-artikolu 8 ta' l-Att prinċipali għandu jiżdied l-artikolu ġdid li ġej:

Żieda ta' artikolu ġdid 8A ma' l-Att prinċipali.

"Il-biljetti tal-Lotterija l-Kbira jkollhom parti stakkabbli.

8A. Il-biljetti tal-Lotterija l-Kbira għandu jkollhom parti stakkabbli li testendi minnhom, hawnhekk iżjed 'il quddiem f'dan l-Att imsejha "il-parti stakkabbli", li ġġib l-istess numru tal-biljett. Il-ġugatur jista' jikteb ismu u l-indirizz tiegħu fuq il-parti stakkabbli li tista' tintbagħat personalment jew bil-posta lid-Direttur qabel it-tluġh relattiv tal-Lotterija l-Kbira:

Iżda d-Direttur ma jkunx responsabbli f'każ li għal xi raġuni li tkun huwa ma jirċevix il-parti stakkabbli jew jekk għal xi raġuni dik il-parti ma tkunx tista' tinstab."

3. Minnufih wara s-subartikolu (1) ta' l-artikolu 9 ta' l-Att prinċipali għandhom jiżdiedu dawn il-provisos li ġejjin:

Emenda ta' l-artikolu 9 ta' l-Att prinċipali.

“Iżda, meta wara li jkunu għaddew hamsin ġurnata tax-xogħol wara tluġh, persuna tipproduċi għas-sodisfazzjon tad-Direttur prova biżżejjed li tidentifikaha bhala s-sid leġittimu tal-biljett rebbieh tal-Lotterija l-Kbira, id-Direttur jista', fid-diskrezzjoni assoluta tiegħu, jagħti l-premju lil dik il-persuna wkoll jekk il-biljett rebbieh ma jiġix preżentat;

Iżda wkoll id-Direttur għandu sommarjament jirrifjuta talba jekk il-parti stakkabbli tal-biljett rebbieh ma tkunx fil-pussess tiegħu.”.

ACT No. XXVII of 1988

AN ACT further to amend the Government Lotteries Act, 1981.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Government Lotteries (Amendment) Act, 1988, and shall be read and construed as one with the Government Lotteries Act, 1981, hereinafter referred to as “the principal Act”.

Short title and commencement. Act XXIV of 1981.

(2) The provisions of this Act shall be deemed to have come into force on the 1st September, 1988.

2. Immediately after section 8 of the principal Act there shall be added the following new section:

Addition of new section 8A to the principal Act.

“Grand Lottery tickets to have detachable portion.”

8A. The tickets of the Grand Lottery shall have an extended detachable portion, hereinafter in this Act referred to as the “detachable portion”, bearing the same number as the ticket. The staker may write down his name and address on the detachable portion which may be delivered by hand or by post to the Director before the relative Grand Lottery draw:

Provided that no liability shall attach to the Director in the event that for any reason whatsoever the detachable portion is not received by him or cannot for any reason be traced.”.

3. Immediately after subsection (1) of section 9 of the principal Act there shall be added the following provisos:

Amendment of section 9 of the principal Act.

“Provided that where, after the lapse of fifty working days after a draw, a person produces to the satisfaction of the Director sufficient proof to identify him as the rightful owner of a winning Grand Lottery ticket, the Director may, in his absolute discretion, pay the price to such person even if the winning ticket is not presented;

Provided further that the Director shall summarily dismiss a claim if the detachable portion of the winning ticket is not in his possession.”.
