2. Is-subartikolu (1) ta' l-artikolu 15 ta' l-Att prinċipali għandu jġi emendat kif ġej:—

ACT No. IV of 1989

AN ACT further to amend the Hotels and Catering Establishments Act, 1967.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Hotels and Catering Establishments (Amendment) Act, 1989, and shall be read and construed as one with the Hotels and Catering Establishments Act, 1967, hereinafter referred to as "the principal Act".

2. Subsection (1) of section 15 of the principal Act shall be amended as follows:—

(a) paragraph (f) thereof shall be renumbered as paragraph (g); and

(b) immediately after paragraph (e) thereof there shall be inserted the following new paragraph:—

“(f) establishing or enabling the Board to establish the minimum facilities and services that are to be provided in

hotels, hostels and catering establishments of any class, and fixing or empowering the Board to fix the prices for such facilities and services;”.
