(d) fis-subartikolu (3) tiegħu kif enumerat mill-ġdid minflok il-kliem “tlielaq taż-żwiemel jew xi xorta ohra ta’ *sport* atletiku” għandhom jidhlu l-kliem “tlielaq taż-żwiemel, wirjiet ta’ films jew xi xorta ohra ta’ *sport* atletiku.”.

**ACT No. VI of 1989**

*AN ACT further to amend the Entertainments Tax Act, 1974.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Entertainments Tax (Amendment) Act, 1989, and shall be read and construed as one with the Entertainments Tax Act, 1974, hereinafter referred to as "the principal Act".

Short title.

2. Section 6 of the principal Act shall be amended as follows:

(a) in subsection (1) thereof the words "other than a film show," shall be deleted;

(b) subsection (2) thereof shall be deleted;

(c) subsections (3) and (4) thereof shall be renumbered respectively as subsections (2) and (3) thereof; and

(d) in subsection (3) thereof as renumbered for the words "horse racing or any form of athletic sport" there shall be substituted the words "horse racing, film shows or any form of athletic sport."
