2. L-artikolu 8 tal-ligi prinċipali għandu jiġi emendat kif ġej:

(a) id-dispożizzjoni li hemm għandha tiġi enumerata mill-ġdid bħala s-subartikolu (1) ta' l-artikolu; u

(b) minnufih wara s-subartikolu (1) tiegħu kif enumerat mill-ġdid għandu jiżdied dan is-subartikolu ġdid li ġej:

“(2) Id-dispożizzjonijiet ta' dan l-artikolu ma għandhomx japplikaw:

(a) meta l-piż totali ta' kull oġġett bħal dak ma jkunx iżjed minn gramma; u

(b) meta, fil-fehma tal-Konslu, l-imbullar tal-marka ta' l-artigjan jista' ma jsirx minhabba f'diffikultajiet teknici eċċezzjonali.”.

**ACT No. XVIII of 1990**

*AN ACT further to amend the Goldsmiths and Silversmiths Ordinance,  
Cap. 46.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Goldsmiths and Silversmiths (Amendment) Act, 1990, and shall be read and construed as one with the Goldsmiths and Silversmiths Ordinance, hereinafter referred to as “the principal law”. Short title and commencement. Cap. 46.

(2) This Act shall be deemed to have come into force on the 19th January, 1990.

2. Section 8 of the principal law shall be amended as follows: Amendment of section 8 of the principal law.

(a) the present provision shall be renumbered as subsection (1) thereof; and

(b) immediately after subsection (1) thereof as renumbered there shall be added the following new subsection:

“(2) The provisions of this section shall not apply:

(a) where the total weight of any such article does not exceed one gram; and

(b) where, in the opinion of the Consul, the stamping of the artificer's mark may be dispensed with because of exceptional technical difficulties.”.
