**ACT No. XXIV of 2023**

*An ACT to amend the Consumer Affairs Act, Cap. 378, and the Consumer Claims Tribunal Rules to increase the competence of the Consumer Claims Tribunal and to make ancillary and consequential provisions thereto.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

**1.** (1) The short title of this Act is the Consumer Affairs Act and the Consumer Claims Tribunal Rules (Amendment) Act, 2023. Short title and commencement.

(2) This Act shall come into force on such date or dates as the Minister may by notice in the Gazette establish, and different dates may be so established for different provisions and for different purposes of this Act.

**PART I**

**Amendments to the Consumer Affairs Act**

**2.** This Part amends the Consumer Affairs Act and shall be read and construed as one with the Consumer Affairs Act, hereinafter in this Part referred to as "the principal Act". Amendments to the Consumer Affairs Act. Cap. 378.

Amendment of article 20 of the principal Act.

**3.** Article 20 of the principal Act shall be amended by the following:

(a) in sub-article (1) thereof, the words "does not exceed five thousand euro (€5,000)" shall be substituted by the words "does not exceed ten thousand euro (€10,000)"; and

(b) in the proviso to paragraph (b) of sub-article (2) thereof, the words "exceeds five thousand euro (€5,000)" shall be substituted by the words "exceeds ten thousand euro (€10,000)".

## **PART II**

### **Amendments to the Consumer Claims Tribunal Rules**

**4.** This Part amends the Consumer Claims Tribunal Rules and shall be read and construed as one with the Consumer Claims Tribunal Rules, hereinafter referred to as "the principal rules".

Provided that where a claim before the Tribunal is filed electronically outside Registry opening hours, such claim shall be deemed to have been filed on the first following day of the opening of the said Registry"; and

(b) in sub-rule 3.4 thereof, the words "five thousand euro (€5,000)" shall be substituted by the words "ten thousand euro (€10,000)".

**7.** Sub-rule 4.2.A of rule 4 of the principal rules shall be substituted by the following new sub-rule:

"4.2.A. A reply to a claim may also be filed by registered 'advice of receipt' mail or electronically through the dedicated online portal:

Provided that where a reply to a claim before the Tribunal is filed electronically outside Registry opening hours, such reply shall be deemed to have been filed on the first following day of the opening of the said Registry."

**8.** In sub-rule 5.3 of rule 5 of the principal rules, the words "five thousand euro (€5,000)" shall be substituted by the words "ten thousand euro (€10,000)".

**9.** Immediately after sub-rule 11.7 of rule 11 of the principal rules there shall be added the following new sub-rule:

"Presence through live video conferencing link.

11.7.A. (1) In any claim, the Tribunal may on application of one of the parties or *ex officio*, declare that any party or witness in a remote location shall be treated as being present in the Tribunal for any part of the proceedings, or for the entirety of the proceedings.

(2) The Tribunal shall not give an order under sub-rule (1) unless:

(a) it is satisfied that facilities are available which enable persons in the remote location to participate in an active manner in the sitting presided by the Tribunal;

(b) if it is unfair to any of the parties to hold sittings by live video conferencing links; or

(c) if it is contrary to the interests of justice to do so.

(3) If the Tribunal decides not to give an order under sub-rule (1) to hold sittings by video conference links, it shall give its reasons for the refusal.

(4) Without prejudice to the provisions of the Act and to any regulations and rules made thereunder, the Tribunal shall regulate its own procedure for the administration of live video conferencing procedures."
