*AN ACT further to amend the Housing Authority Act, 1976.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.  
Act XV of 1976.

1. This Act may be cited as the Housing Authority (Amendment) Act, 1988, and shall be read and construed as one with the Housing Authority Act, 1976, hereinafter referred to as "the principal Act".

2. In paragraph (a) of subsection (3) of section 4 of the principal Act, for the words "shall act through the agency of the Department of Public Works" there shall be substituted the words "may either act through the agency of the Department of Works, or may carry out such functions by means of a grant of contracts of works".

**Objects and Reasons**

The Object of the Bill is to grant greater flexibility to the Housing Authority in the carrying out of its functions, when such functions involve the erection of buildings etc.
