AN ACT further to amend the Import Duties Act, 1976

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Import Duties (Amendment) (No. 2) Act, 1988 and shall be read and construed as one with the Import Duties Act, 1976, hereinafter referred to as "the principal Act".

Objects and Reasons

The Object of this Bill is to increase the rate of import duty on bulls and **certain** imported meats so as to protect local breeders of cattle.
