*AN ACT further to amend the Ġieh ir-Repubblika Act, 1975.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

Act XXIX  
of 1975.

Amendment of  
section 15  
of the  
principal Act.

1. This Act may be cited as the Ġieh ir-Repubblika (Amendment) (No. 2) Act, 1990, and shall be read and construed as one with the Ġieh ir-Repubblika Act, 1975, hereinafter referred to as “the principal Act”.

2. In subsection (2) of section 15 of the principal Act, for the words “to Maltese citizens” there shall be substituted the words “to persons”.

**Objects and Reasons**

The Object of the Bill is to make possible the grant of National Commemorative Medals to persons who are not citizens of Malta.
