entitled**

AN ACT to amend the Import Duties Act, 1989.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Import Duties (Amendment) Act, 1990, and shall be read and construed as one with the Import Duties Act, 1989, hereinafter referred to as “the principal Act”. Short title and commencement. Act XXXV of 1989.

(2) The provisions of paragraphs 2 to 7 of the Schedule to this Act shall be deemed to have come into force on the 5th December, 1990.

2. The First Schedule to the principal Act shall have effect subject to the amendments set out in the Schedule to this Act. Amendment of First Schedule to the principal Act.

SCHEDULE

(Section 2)

1. For heading number 22.02 and the figures in respect thereof in the first, second and third columns, there shall be substituted respectively the heading shown in the first column and the relative figures shown in the second and third columns hereunder:

2. For the words "Lm18.00,0 per Kg." in the Second and Third columns in respect of heading number 2402.10.00, there shall be substituted in each case the words "Lm22.20,0 per Kg."

3. For the words "Lm20.00,0 per Kg." in the Second and Third columns in respect of heading number 2402.20.00, there shall be substituted in each case the words "Lm24.20,0 per Kg."

4. For the words "Lm18.00,0 per Kg." in the Second and Third columns in respect of heading number 2402.90.10, there shall be substituted in each case the words "Lm22.20,0 per Kg."

5. For the words "Lm20.00,0 per Kg." in the Second and Third columns in respect of heading number 2402.90.90, there shall be substituted in each case the words "Lm24.20,0 per Kg."

6. For the words "Lm11.00,0 per Kg." in the Second and Third columns in respect of heading number 2403.10.10, there shall be substituted in each case the words "Lm13.80,0 per Kg."

7. For the words "Lm11.00,0 per Kg." in the Second and Third columns in respect of heading number 2403.99.10, there shall be substituted in each case the words "Lm13.80,0 per Kg."
