AN ACT further to amend the Machine-made Cigarettes (Excise Duty) Act, Cap. 57.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title and commencement.

Cap. 57.

1. (1) This Act may be cited as the Machine-made Cigarettes (Excise Duty) (Amendment) Act, 1990, and shall be read and construed as one with the Machine-made Cigarettes (Excise Duty) Act, hereinafter referred to as “the principal Act”.

(2) This Act shall be deemed to have come into force on the 5th December, 1990.

Amendment of section 3 of the principal Act.

2. In subsection (1) of section 3 of the principal Act, for the words “five cents” there shall be substituted the words “eight cents five mils”.

Amendment of section 5 of the principal Act.

3. In subsection (1) of section 5 of the principal Act, for the words “five cents” there shall be substituted the words “eight cents five mils”

Objects and Reasons

The Object of the Bill is to increase excise duty on certain products as announced in the Budget speech for the year 1991.
