ATT biex jemenda l-Ordinanza dwar Self Lokali (*Stock u Titoli Registrati*), Kap. 161.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. Dan l-Att jista' jissejjah l-Att ta' l-1991 li jemenda l-Ordinanza dwar Self Lokali (*Stock u Titoli Registrati*), u għandu jinqara u jiftiehem haġa waħda ma' l-Ordinanza dwar Self Lokali (*Stock u Titoli Registrati*), hawnhekk iżjed 'il quddiem imsejjah "il-liġi prinċipali".

Titolu fil-qosor.

Kap. 161.

2. Minnufih wara l-artikolu 43 tal-liġi prinċipali għandu jiżdied dan l-artikolu ġdid li ġej:

Żieda ta' artikolu ġdid mal-liġi prinċipali.

44. Minkejja kull haġa oħra li tinsab f'din l-Ordinanza, id-dispożizzjonijiet li jirrigwardaw ir-registrazzjoni u l-hruġ ta' ċertifikati ta' *stock* ma għandhomx japplikaw fil-każ ta' kull hruġ ta' *stock* registrat u titoli tal-Gvern li jistghu jigu negozjati fil-Borsa ta' Malta skond l-Att ta' l-1990 dwar il-Borsa ta' Malta."

Għanijiet u Raġunijiet

L-Għan ta' l-Abbozz huwa sabiex jillimita l-effett ta' ċerti dispożizzjonijiet ta' l-Ordinanza dwar Self Lokali (*Stock u Titoli Registrati*) dwar ir-registrazzjoni ta' *stock* u obligazzjonijiet u l-hruġ ta' ċertifikati ta' *stock* għal kull hruġ ta' *stock* registrat u titoli tal-Gvern li jkunu ġew elenkati mill-Borsa ta' Malta.

AN ACT to amend the Local Loans (Registered Stock and Securities) Ordinance, Cap. 161.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:—

Short title.

Cap. 161.

Addition of new section to the principal law.

1. This Act may be cited as the Local Loans (Registered Stock and Securities) (Amendment) Act, 1991 and shall be read and construed as one with the Local Loans (Registered Stock and Securities) Ordinance, hereinafter referred to as "the principal law".

2. Immediately after section 43 of the principal law there shall be added the following new section:

44. Notwithstanding anything contained in this Ordinance, the provisions concerning any registration and the issuing of stock certificates shall not apply in the case of the issues of Government registered stock and securities which may be traded on the Malta Stock Exchange under the Malta Stock Exchange Act, 1990."

Objects and Reasons

The Object of the Bill is to limit the effect of certain provisions of the Local Loans (Registered Stock and Securities) Ordinance regarding the registration of stocks and debentures and the issue of stock certificates for issues of Government registered stock and securities which have obtained a listing from the Malta Stock Exchange.
