IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'ligi dan li ġej:—

1. Dan l-Att jista' jissejjah l-Att ta' l-1991 li jemenda l-Att dwar it-Taxxa fuq l-*Income*, u għandu jinqara u jiftiehem haġa waħda ma' l-Att dwar it-Taxxa fuq l-*Income*, hawnhekk iżjed "il quddiem imsejjah "l-Att prinċipali".

(2) Id-dispożizzjonijiet ta' dan l-Att għandhom jibdew isehħu kif ġej:

(a) id-dispożizzjonijiet ta' dan l-artikolu għandhom jibdew isehħu mal-pubblikazzjoni ta' dan l-Att fil-Gazzetta; u

(b) id-dispożizzjonijiet ta' l-artikoli 2 u 3 għandhom jibdew isehħu mal-pubblikazzjoni ta' dan l-Att fil-Gazzetta, dwar is-sena ta' stima li tibda fl-1 ta' Jannar, 1992 u dwar is-snin ta' stima ta' wara.

2. Is-subartikolu (1) ta' l-artikolu 11 ta' l-Att prinċipali għandu jiġi emendat kif ġej:

(a) fil-paragrafu (n) tiegħu minflok il-kliem "l-Att:" għandhom jidhlu l-kliem "l-Att;"; u

(b) minnufih wara l-paragrafu (n) tiegħu għandu jizded dan il-paragrafu (o) ġdid li ġej:

“(o) l-*income* ta' għaqda koperativa.”.

Zieda ta' artikolu 31B ġdid ma' l-Att prinċipali.

3. Minnufih wara l-artikolu 31A ta' l-Att prinċipali, għandu jiżdied dan l-artikolu 31B ġdid li ġej:

"Iktar *rebate*.

31B. Fil-każ ta' individwu ordinarjament residenti u domiciljat f'Malta, it-taxxa intaxxata għal kull sena ta' stima fuq *l-income* taxxabbli ta' kull tali individwu għas-sena li tiġi minnufih qabel is-sena ta' stima għandha tiġi iktar *rebated* b'ammont ta' tnejn u hamsin lira."

ACT No. VIII of 1991

AN ACT to amend the Income Tax Act, Cap. 123.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Income tax (Amendment) Act, 1991, and shall be read and construed as one with the Income Tax Act, hereinafter referred to as "the principal Act".

(2) The provisions of this Act shall come into force as follows:

(a) the provisions of this section shall come into force upon the publication of this Act in the Gazette; and

(b) the provisions of sections 2 and 3 shall come into force upon the publication of this Act in the Gazette, in respect of the year of assessment commencing on the 1st January, 1992 and of subsequent years of assessment.

2. Subsection (1) of section 11 of the principal Act shall be amended as follows:

(a) in paragraph (n) thereof for the word "Act:", there shall be substituted the word "Act;"; and

(b) immediately after paragraph (n) thereof there shall be added the following new paragraph (o):

"(o) the income of a co-operative society."

3. Immediately after section 31A of the principal Act, there shall be added the following new section 31B:

"Further
rebate.

31B. In the case of an individual ordinarily resident and domiciled in Malta, tax charged for each year of assessment upon the chargeable income of every such individual for the year immediately preceding the year of assessment shall be further rebated by an amount of fifty-two liri."
