**ACT No. VII of 1983**

*AN ACT further to amend the Traffic Regulation Ordinance, Cap. 105.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title and commencement.

1. (1) This Act may be cited as the Traffic Regulation (Amendment) Act, 1983, and shall be read and construed as one with the Traffic Regulation Ordinance, hereinafter referred to as “the principal law”.

(2) This Act shall come into force seven days after its enactment.

Substitution of Second Schedule to the principal law.

2. For the Second Schedule to the principal law there shall be substituted the following:
