## ACT No. 1 of 1985

*AN ACT further to amend the Commissioners for Justice Act, 1981.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Commissioners for Justice (Amendment) Act, 1985, and shall be read and construed as one with the Commissioners for Justice Act, 1981, hereinafter referred to as “the principal Act”. Short title.

2. For item 5 of the Schedule to the principal Act there shall be substituted the following: Amendment of  
the Schedule to  
the principal Act.

“5. *Traffic Signs and Carriageway Markings Regulations, 1969*

Regulation 2.”.

Transitory  
provision.

3. Notwithstanding the provisions of section 2 of this Act, the provisions of the principal Act shall continue to apply to any offence under regulation 17 of the Agricultural Produce (Marketing) Regulations, 1952 committed before the coming into force of this Act.
