ATT biex ikompli jemenda l-Att ta' l-1980 dwar ir-Revizjoni tal-Liġijiet Statutarji.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati; imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. Dan l-Att jista' jissejjah l-Att ta' l-1985 li jemenda l-Att dwar ir-Revizjoni tal-Liġijiet Statutarji, u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1980 dwar ir-Revizjoni tal-Liġijiet Statutarji, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

Titolu fil-qosor.

2. L-artikolu 7 tal-liġi prinċipali għandu jiġi emendat kif ġej:

Emenda ta' l-artikolu 7 tal-liġi prinċipali.

(a) id-dispożizzjoni preżenti għandha tiġi numerata mill-ġdid bħala subartikolu (1); u

(b) minnufih wara s-subartikolu (1) kif numerat mill-ġdid għandu jiżdied is-subartikolu ġdid li ġej:

“(2) Meta taqsimiet ta' edizzjoni riveduta jingiebu fis-schħ f'dati differenti, u f'parti li tkun fis-sehħ ikun hemm riferenza għal leġislazzjoni, jew għal dispożizzjoni tagħha, kif dik il-leġislazzjoni jew dispożizzjoni tkun ser tiġi mqiegħda f'xi parti

ta' l-istess edizzjoni li tkun ghadha mhux fis-sehh, dik ir-riferenza ghandha, sakemm il-parti l-ahhar imsemmija tigi fis-sehh, tingara bhala riferenza ghal-legislazzjoni jew dispozizzjoni taghha korrispondenti kif tkun dak iz-zmien fis-sehh.”.

ACT No. VIII of 1985

AN ACT further to amend the Statute Law Revision Act, 1980.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Statute Law Revision (Amendment) Act, 1985 and shall be read and construed as one with the Statute Law Revision Act, 1980, hereinafter referred to as "the principal Act". Short title.

2. Section 7 of the principal Act shall be amended as follows: Amendment
of section 7
of the
principal Act.

(a) the present provision shall be re-numbered as subsection (1); and

(b) immediately after subsection (1) as re-numbered there shall be added the following new subsection:

“(2) Where parts of a revised edition are brought into force on different dates, and in a part which is in force reference is made to an enactment, or a provision of an enactment, as such an enactment or provision will be contained in a part of

the same edition which is not yet in force, such reference shall, until such time as the latter part comes into force, be read as a reference to the corresponding enactment or provision thereof as then in force.”.
