**ACT No. XIV of 1985**

*AN ACT further to amend the Notarial Profession and Notarial Archives Act, Cap. 92.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Notarial Profession and Notarial Archives (Amendment) Act, 1985, and shall be read and construed as one with the Notarial Profession and Notarial Archives Act, hereinafter referred to as “the principal Act”.

Amendment of section 6 of the principal Act.

2. For paragraph (e) of section 6 of the principal Act there shall be substituted the following:

“(e) he has regularly attended at the office of a practising notary for a period of not less than one year after the end of the last academic year of the course.”.
