ATT sabiex jemenda l-Att dwar il-Governanza Sportiva u l-Integrità fl-Isport, Kap. 626.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità tal-istess ħareġ b'liġi dan li ġej:-

1. It-titolu fil-qosor ta' dan l-Att hu l-Att tal-2023 li jemenda l-Att dwar il-Governanza Sportiva u l-Integrità fl-Isport u għandu jinqara u jinftiehem haġa waħda mal-Att dwar il-Governanza Sportiva u l-Integrità fl-Isport, hawn iżjed 'il quddiem imsejjaħ "l-Att prinċipali".

Titolu fil-qosor.

2. Fis-subartikolu (3) tal-artikolu 44 tal-Att prinċipali, il-kliem "jagħmel regolamenti dwar il-kompożizzjoni" għandhom jiġu sostitwiti bil-kliem "jagħmel regolamenti dwar it-twaqqif, il-kompożizzjoni u l-personalità legali distinta".

Emenda tal-artikolu 44 tal-Att prinċipali.

3. Is-subartikolu (2) tal-artikolu 73 tal-Att prinċipali għandu jiġi emendat kif ġej:

Emenda tal-artikolu 73 tal-Att prinċipali.

(a) fil-paragrafu (e) tiegħu, il-kliem "jew tinforza; u" għandhom jiġu sostitwiti bil-kliem "jew tinforza;"; u

(b) fil-paragrafu (f) tiegħu, il-kliem "ta' dan l-Att." għandhom jiġu sostitwiti bil-kliem "ta' dan l-Att; u" u minnufih wara għandu jiġi miżjud dan il-paragrafu ġdid li ġej:

"(g) iwaqqaf pjattaformi u, jew entitajiet godda li jkollhom personalità legali distinta mill-membri u mill-Awtorità.".

AN ACT to amend the Sports Governance and Integrity Act, Cap. 626.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. The short title of this Act is the Sports Governance and Integrity (Amendment) Act, 2023 and this Act shall be read and construed as one with the Sports Governance and Integrity Act, hereinafter referred to as "the principal Act".

Short title.

Cap. 626.

2. In sub-article (3) of article 44 of the principal Act, the words "make regulations as to the composition" shall be substituted by the words "make regulations as to the establishment, the composition and the distinct legal personality".

Amendment of article 44 of the principal Act.

3. Sub-article (2) of article 73 of the principal Act shall be amended as follows:

Amendment of article 73 of the principal Act.

(a) in paragraph (e) thereof, the words "or enforce; and" shall be substituted by the words "or enforce;"; and

(b) in paragraph (f) thereof, the words "of this Act." shall be substituted by the words "of this Act; and" and immediately after there shall be added the following new paragraph:

"(g) establish new platforms and, or entities having a legal personality distinct from of its members and of the Authority."

The objects and reasons of this Bill are to amend the Sports Governance and Integrity Act (Cap. 626) for the formation of platforms and entities in the fight against corruption in sports and in favour of sports integrity.
