### ACT No. V of 1987

*An Act further to amend the Education Act, 1974.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Education (Amendment) Act, 1987, and shall be read and construed as one with the Education Act, 1974, hereinafter referred to as "the principal Act". Short title.

2. In the Maltese text of subsection (5) of section 39 of the principal Act, immediately after the words "b'hala haddiema-studenti numru" there shall be inserted the words "ta' persuni b'zjeda ma' daw k l-impjegati". Amendment of  
section 39 of the  
principal Act.
  
3. Immediately after section 39 of the principal Act there shall be added the following new section: Addition of  
new section  
39A to the  
principal Act.

"Preference given to nominated worker-students. 39A. Notwithstanding any other provisions of this Act, only those worker-students who are nominated by their employer and who on the 15th of February of the year in which they are to be admitted to the University are over twenty-five years of age and have been in continuous, full-time employment with the employer nominating them for a period of at least one year, and on the basis of such other requirements, including age and grade, as the employer may determine, shall be given preference in the selection by the Selection Board."

Application.

**4.** This Act shall apply to the selection of students for entry in the University after the 1st day of January, 1987.
