ACT No. IX of 2024

AN ACT to further amend the Sports Governance and Integrity Act, Cap. 626.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. (1) The short title of this Act is the Sports Governance and Integrity (Amendment No. 2) Act, 2024 and this Act shall be read and construed as one with the Sports Governance and Integrity Act, hereinafter referred to as "the principal Act".

Short title and commencement.
Cap. 626.

(2) This Act shall come into force on such date as the Minister responsible for sport may by notice in the Gazette establish, and different dates may be so established for different provisions and purposes of this Act.

2. In sub-article (3) of article 38 of the principal Act the words "Any athlete who is found to have made use of prohibited substances with intent and without a valid therapeutic use exemption, or any person who is found to have administered prohibited substances, with intent, to an athlete whilst acting as that athlete's support person" shall be
