IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjah l-Att ta' l-1976 li jemenda l-Att dwar Ġieħ ir-Repubblika, u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1975 dwar Ġieħ ir-Repubblika, hawnhekk iżjed 'il quddiem im-sejjah "l-Att prinċipali".

Emenda ta' l-artikolu 9 ta' l-Att prinċipali.

2. Fl-artikolu 9 ta' l-Att prinċipali għandu jżiddied is-subartikolu ġdid li ġej minnufih wara s-subartikolu (2):

“(3) Il-“Midalja għall-Qadi tar-Repubblika” tista' tingħata wkoll wara l-mewt.”.

A BILL
entitled

AN ACT to amend the Ġieħ ir-Repubblika Act, 1975.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the *Ġieħ ir-Repubblika (Amendment) Act, 1976*, and shall be read and construed as one with the *Ġieħ ir-Repubblika Act, 1975*, hereinafter referred to as “the principal Act”. Short title.

2. In section 9 of the principal Act there shall be added the following new subsection immediately after subsection (2): Amendment of section 9 of the principal Act.

“(3) The “*Midalja għall-Qadi tar-Repubblika*” may also be awarded posthumously.”.

Objects and Reasons

The Object of this Bill is to make possible the posthumous award of the *Midalja għall-Qadi tar-Repubblika*.
