AN ACT further to amend the Agricultural Leases (Reletting) Act, 1967.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Agricultural Leases (Reletting) (Amendment) Act, 1979, and shall be read and construed as one with the Agricultural Leases (Reletting) Act, 1967, hereinafter referred to as "the principal Act".

Short title
and

(2) This Act shall have effect as from the 1st April, 1976.

2. For paragraph (a) of section 16A of the principal Act there shall be substituted the following:

"(a) a fee of four pounds for every attendance to a sitting of the Board, and".

Objects and Reasons

The Object of this Bill is to increase the fee due to members of the Rural Leases Control Board.
