ATT biex ikompli jemenda l-Att ta' 1-1970 dwar il-Forzi Armati ta' Malta.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjah l-Att ta' 1-1980 li jemenda l-Att dwar il-Forzi Armati ta' Malta, u għandu jinqara u jfithem haġa waħda ma' l-Att ta' 1-1970 dwar il-Forzi Armati ta' Malta, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

Emenda ta' l-artikolu 4 ta' l-Att prinċipali.

2. Minnufih wara s-subartikolu (2) ta' l-artikolu 4 ta' l-Att prinċipali għandu jżied is-subartikolu ġdid li ġej:

“(2A) Il-President jista' b'ordni jagħti s-setgħa lil kull membru tal-forza li jeżerċita, b'zieda mal-funzjonijiet, setgħat u dmirijiet li għandu bhala membru ta' dik il-forza, daww il-funzjonijiet, setgħat u dmirijiet kollha, jew tlied minnhom, li b'liġi huma vestiti f'membri tal-Korp tal-Pulizija ta' Malta u l'uffiċjali tad-Dwana.”.

Għanijiet u Ragunijiet

L-Għan ewlieni ta' dan l-Abbozz huwa li jipprovdi sabieħ il-Forzi Armati ta' Malta jkun jistgħu jingħataw is-setgħat li għandhom il-Pulizija u l'uffiċjali tad-Dwana.

A BILL
entitled

AN ACT further to amend the Malta Armed Forces Act, 1970.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Malta Armed Forces (Amendment) Act, 1980, and shall be read and construed as one with the Malta Armed Forces Act, 1970, hereinafter referred to as “the principal law”.

Short title.

2. Immediately after subsection (2) of section 4 of the principal law there shall be added the following new subsection:

Amendment of section 4 of the principal law.

“(2A) It shall be lawful for the President by order to empower any member of the force to exercise, in addition to any functions, powers and duties he may have as a member of the force, all or any one or more of the functions, powers and duties as are by law vested in a member of the Malta Police Force and in an officer of the Customs.”.

Objects and Reasons

The main Object of this Bill is to provide for vesting the Armed Forces of Malta with powers of the Police and officers of the Customs.
