IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjah l-Att ta' l-1981 li jemenda l-Ordinanza dwar l-Ilma ta' Taħt l-Art, u għandu jinqara u jiftiehem haġa waħda ma' l-Ordinanza dwar l-Ilma ta' Taħt l-Art, hawnhekk iżjed 'il quddiem imsejja "il-liġi prinċipali".

Emenda ta' l-artikolu 3 tal-liġi prinċipali.

2. Fis-subartikolu (1) ta' l-artikolu 3 tal-liġi prinċipali minflok il-kliem "li fosthom wiehed ikun il-Maniġer tal-Ferġha ta' l-Ilma" għandhom jidhlu l-kliem "li fosthom wiehed ikun il-Manager tad-Dipartiment ta' l-Ilma jew ir-rappreżentant tiegħu, jew rappreżentant tad-Dipartiment ta' l-Ilma maħtur mill-Ministru responsabbli għad-Dipartiment ta' l-Ilma."

Emenda ta' l-artikolu 8 tal-liġi prinċipali.

3. Fis-subartikolu (2) ta' l-artikolu 8 tal-liġi prinċipali, minflok il-kliem "sitt piedi" kull fejn jinsabu, għandhom jidhlu f'kull każ il-kliem "żewġ metri".

Emenda tat-Tieni Skeda li tinsab mal-liġi prinċipali.

4. Fit-Tieni Skeda li tinsab mal-liġi prinċipali, minflok il-kelma "jarda" għandha tidhol il-kelma "metru".

*AN ACT further to amend the Underground Water Ordinance, 1943.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

| <p><b>1.</b> This Act may be cited as the Underground Water (Amendment) Act, 1981, and shall be read and construed as one with the Underground Water Ordinance, hereinafter referred to as "the principal law".</p>   | <p>Short title.</p>   |
| <p><b>2.</b> In subsection (1) of section 3 of the principal law for the words "of whom one shall be the Manager of the Water Works Department" there shall be substituted the words "of whom one shall be the Manager of the Water Works Department or his representative, or a representative of the Water Works Department appointed by the Minister responsible for the Department of Water."</p> | <p>Amendment of section 3 of the principal law.</p>           |
| <p><b>3.</b> In subsection (2) of section 8 of the principal law, for the words "six feet" wherever they occur, there shall be substituted in each case the words "two metres".</p>   | <p>Amendment of section 8 of the principal law.</p>           |
| <p><b>4.</b> In the Second Schedule to the principal law, for the word "yards" there shall be substituted the word "metres".</p>  | <p>Amendment of the Second Schedule to the principal law.</p> |
