Minkejja kull haġa li tinsab fil-Kodiċi ta' Organizzazzjoni u Proċedura Ċivili jew f'xi ligi oħra, il-kawżi kollha li kellhom jinstemgħu quddiem xi waħda mill-Qrati Superjuri fit-3 jew wara t-3 ta' Jannar, 1981, u li għal xi raġuni ma ġewx differiti mill-Qorti għal data stabbilita, għandhom jitqiesu li ġew differiti għat-3 ta' Marzu, 1981, iżda f'dik id-data dawk il-kawżi għandhom jerġgħu jigu differiti għal jiem oħra sabiex il-Qorti tkun tista' timxi għal kolloxx fuq il-ligijiet tal-proċedura li jkunu fis-seħħ f'dik id-data.

**A BILL**  
**entitled**

*AN ACT to make provision with respect to the adjournment of certain causes before the Superior Courts.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Special Adjournment of Causes Act, 1981. Short title.
2. Notwithstanding anything contained in the Code of Organization and Civil Procedure or in any other law, all causes which were due for hearing before any of the Superior Courts on or after January 3, 1981, and which are not for any reason adjourned by the Court to a fixed date, shall be deemed to have been adjourned to March 3, 1981, but such causes shall on that date again be adjourned to such dates as will enable the Court fully to comply with the laws of procedure in force on that date. Adjournment of certain causes due for hearing after January 3, 1981.
3. Without prejudice to anything done thereunder, this Act shall cease to be in force on March 31, 1981. Act to cease to be in force on March 31, 1981.

**Objects and Reasons**

The Object of this Bill is to adjourn all causes which were due for hearing on or after January 3, 1981, to a fixed date and to provide that on that date the Court shall so re-arrange the lists of those causes as will enable it fully to comply with the new laws procedure.
