A BILL**entitled**

AN ACT to make provision in respect of a Development Plan for the period 1981-85.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Development Plan for Malta 1981-85 Act, 1981. Short title.

2. The Development Plan for Malta 1981-85 published in the English language by the Economic Division of the Office of the Prime Minister in August, 1981, in the book entitled "MALTA — Guidelines for Progress", shall for all intents and purposes of this Act be deemed to be the plan which shall serve as a basis and guide for promoting and sustaining a steady economic and social progress in Malta through the years from 1981 to 1985. Development Plan.

Objects and Reasons

The Object of this Bill is to enable the House to discuss and approve the plan published in the book entitled "MALTA — Guidelines for Progress" as the development plan for Malta from 1981 to 1985.
