1. "(a) ma jkunux ta' kapaċità ta' iżjed minn litru meta jkun fihom ilma spa artifiċjali u ma jkunux ta' kapaċità ta' iżjed minn sitta u tletin ċentilitru meta jkun fihom xi xorb iehor mhux-alkoholiku; u".

**ACT No. XXI of 1977**

*AN ACT further to amend the Excise Duty (Crown Corks and Non-alcoholic Concentrates) Ordinance, 1961.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Excise Duty (Crown Corks and Non-alcoholic Concentrates) (Amendment) Act, 1977, and shall be read and construed as one with the Excise Duty (Crown Corks and Non-alcoholic Concentrates) Ordinance, 1961, hereinafter referred to as "the principal law".

Short title.

2. For paragraph (a) of section 8 of the principal law there shall be substituted the following:

Substitution of section 8 of the principal law.

"(a) do not exceed one litre in capacity when containing artificial spa water and do not exceed thirty-six centilitres in capacity when containing any other non-alcoholic beverage; and".
