2. L-artikolu 21 tal-liġi prinċipali għandu jiġi emendat kif ġej:

(a) is-subartikolu (2) tiegħu għandu jiġi numerat mill-ġdid bħala subartikolu (3), u

(b) minflok is-subartikolu (1) tiegħu għandhom jidhlu s-subartikoli li ġejjin:

"(1) Għandu jkun hemm Bord, li jkun magħruf bħala Bord ta' Arbitraġġ dwar Artijiet, li jkun magħmul minn —

(a) persuna li jkollha, jew li kellha kariga ta' Mħallef, bħala *Chairman*, u

(b) żewġ membri oħra maħtura minn fost persuni li jkollhom il-*warrant* lokali ta' Arkitett u Inġinier Ċivili u li jkun ilhom fil-prattika ta' dik il-professjoni għal mhux inqas minn seba' snin.

(2) *Ic-Chairman* u l-Membri l-oħra tal-Bord ikunu maħtura mill-President tar-Repubblika."

3. Minflok l-artikolu 22 tal-ligi principali għandu jidhhol dan li
gej:

“22. Il-membri tal-Bord, barra miċ-*Chairman* meta dan ikollu l-kariga ta' Mhallel, għandhom, malli jiġu maħtura membri, jieħdu quddiem l-Avukat Generali qabel l-ewwel seduta wara li jkunu maħtura l-gurament illi jeżaminaw u jiddeċiedu r-rikors bil-haqq skond il-ligi.”.

ACT No. XVII of 1979

AN ACT further to amend the Land Acquisition (Public Purposes) Ordinance, Cap. 136.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Land Acquisition (Public Purposes) (Amendment) Act, 1979, and shall be read and construed as one with the Land Acquisition (Public Purposes) Ordinance, hereinafter referred to as "the principal law".

Amendment of section 21 of the principal law.

2. Section 21 of the principal law shall be amended as follows:

(a) subsection (2) thereof shall be renumbered as subsection (3), and

(b) for subsection (1) thereof there shall be substituted the following subsections:

"(1) There shall be a Board, to be known as the Land Arbitration Board, which shall consist of—

(a) a person who holds, or has held, the office of Judge, as Chairman, and

(b) two other members appointed from among persons who hold the local warrant of Architect and Civil Engineer and who have practised that profession for not less than seven years.

(2) The Chairman and other Members of the Board shall be appointed by the President of the Republic."

3. For section 22 of the principal law there shall be substituted the following:

"22. The members of the Board, other than the Chairman when he holds the office of Judge, shall, on being appointed members, take before the Attorney General prior to the first sitting after their appointment the oath to examine and decide each application with impartiality according to law."
